Special Off-Site Meeting Location: Tomorrow's Rotary meeting (**Wed, 5/22**) is a Special **OFFSITE Meeting** that will be held at the **Hunterdon County Historical Society's Archive Building** located at 67 River Road – Flemington, NJ 08822. Dick Stothoff noted that everyone should park at the Archives Building, which is where we will have lunch. Dick also noted that he will also walk everyone across the street over to the fully restored **Randy Hoffman House** (which Dick owns), which is one of the oldest buildings in Hunterdon County having been built around 1740. Dick noted the Hoffman house was Governor Reading's first home. The meeting will begin at **12:15pm**. [Click this link to generate driving directions from Google.](#)

Materials not maintained in the Deats Library and two basement archival vaults beneath it are stored in the Historical Society's two-story, all-concrete, state-of-the-art, environmentally-controlled archives building at 67 River Road in Raritan Township, designed to serve archival needs for the next 50 years. Not planned for public use, the building was opened for tours upon its completion in 2009 after ten years of planning and fundraising. Quilt turnings have been held there

and more tours will be scheduled in the future.

A sampling of the Society's collection includes Lenape Indian artifacts; genealogies of 1,200+ Hunterdon families; family bibles; wills; deeds; census, church, civic group and business records; original source historical manuscripts; photographs; maps; quilts; costumes and other textiles; and 1,181 microfilm rolls of County newspapers since 1825 — and more items are continually being added through the generosity of Hunterdon families.

Rotary International Foundation Annual Contributions - \$100 Every Rotarian, Every Year: As you know, all members are encouraged to “Donate \$100 Every Year” to the Rotary International (RI) Foundation. RI initially invests the money for a period of 3-years. After 3-years, RI uses the interest earned to run RI. Then 50% of the original contribution comes back to our Rotary District for our use in Grants, Ambassadorial Scholarships, and other District programs. The remaining 50% of the original contribution goes towards RI’s international humanitarian efforts, including Polio Plus and Clean Water. Once a member has donated a total of \$1000, accrued over time, they are acknowledged with a Paul Harris Recognition. A Rotarian is considered a “sustaining member” if they consistently make a donation on a yearly basis. The separate money collected from the Polio Bee Hives and Polio Pigs supports RI’s Polio Plus program to help eliminate Polio from the world. Pedals for Progress Bicycle, Sewing Machine & Sports Equipment Collection (Sat, June 1): The annual Pedals for Progress collection will be held on **Saturday, June 1, 2013**. Items to be collected include **Used Bicycles** (adult and child), **Used Sewing Machines** (in working condition) and **Sports Equipment** (soccer balls, baseball gloves, etc. that can fit in the shipping containers between the bikes). The collection will take place at the **Flemington Presbyterian Church** located at 10 East Main Street in Flemington, NJ from **9am to 12noon**. The collection is sponsored by the Flemington Presbyterian Church and the Flemington Rotary Club. If there are any questions, please contact Event Chair, Joe Ziegler.

Bikes will be sent to Guatemala, Nicaragua, Albania, Ghana, Uganda and Vietnam. Please help do your part to put unused bikes to good use in the developing world.

Bikes should be rust free. Bikes with flat tires in need of some repair are accepted.
No trikes. “Bikes for parts” are not accepted.

A **\$10 cash donation** is required with each bike or sewing machine. Bikes and donations are cash deductible.

Pedals for Progress, also known as P4P, collects 5000 to 7000 bicycles annually and transfers this material wealth to those needier. To date, more than 133,500 bicycles have been shipped to developing countries in Latin America, Africa, and Eastern Europe. In these countries, the bikes are reconditioned by partner agencies and distributed at low cost to poor working adults. These bikes provide them with reliable transportation for commuting to work, transporting produce to market, or accessing health care and other services. Steady employment for these adults is vital to the development and success for these economies.

It costs \$40 to collect, process, ship, rebuild and distribute each bicycle. The required \$10 donation helps to offset the shipping costs. P4P is a 501(c)(3) corporation and a registered charity in the states of NJ, PA, NY, CT, IA & VT. Brochures explaining this innovative program will be available at the collection site. “Operation Sandy Pants” – A Hurricane Sandy Relief Organization: Operation Sandy Pants is a relief organization that was established to meet the immediate needs of those who were affected by the Hurricane Sandy in October 2012. It was started by Jason Dameo (and his wife Kelly), who is a member of the Rotary Club of Somerville & Bridgewater. It focuses on the devastation that occurred on the barrier islands. Kelly learns of the needs that exist, uses social media to show what is needed, establishes a drop off site for collection of items and drives them to the shore.

Although it is 6 months after the storm, families are still not able to occupy their homes, some cannot even begin to rebuild because there is a large backlog simply waiting to get building permits. There is still no power or gas in many areas. Families who are living in hotels meet every 2 weeks with FEMA to see if they can remain in their current location or have to move. Many children are still not back in their regular schools.

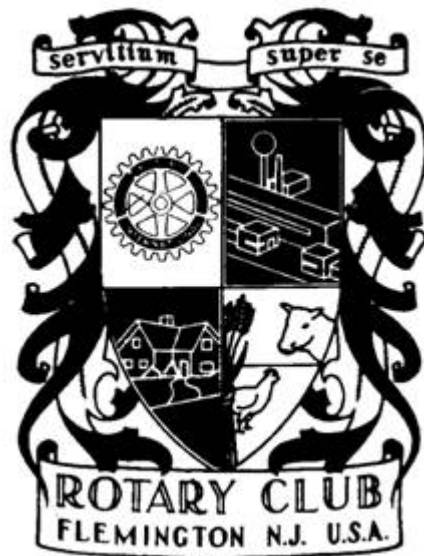
