Participants will be selected on a first come, first-served basis, limited to 25 professional contestants. **Entry deadline is January 29, 2010.**

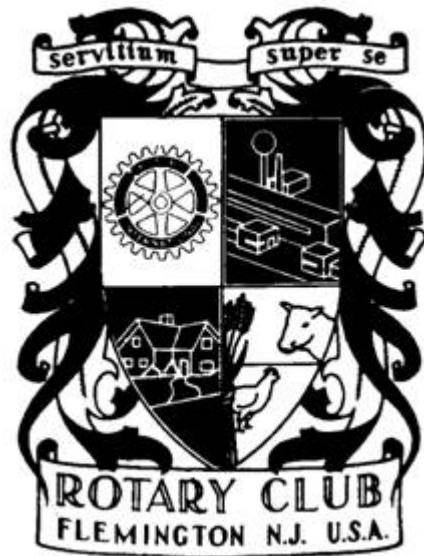
