Participants will be selected on a first come, first-served basis, limited to 25 professional contestants. **Entry deadline is January 29, 2010.**

The Hunterdon County Rotary Soup Cook-Off is a community awareness project of the Rotary Clubs of Hunterdon County, dedicated to helping people in our community. All cook-off proceeds will be donated to the food pantries of Hunterdon County to fight HUNGER IN HUNTERDON.

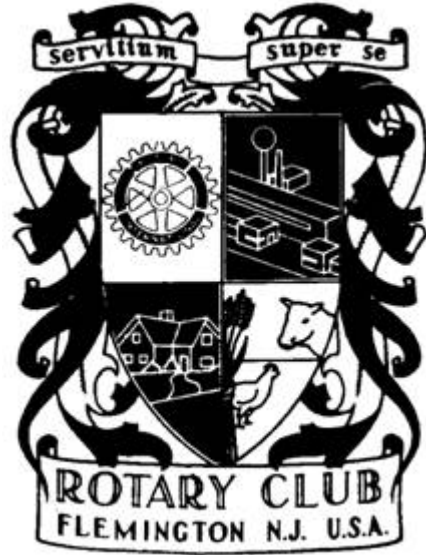
