Incoming GSE Team Visit (April 16th to April 24th): Gwen Williams has shared the final itinerary (below) for the incoming GSE Team (Group Study Exchange). The Group Study Exchange (GSE) program of The Rotary Foundation of Rotary International is a unique cultural and vocational exchange opportunity for young business and professional men and women between the ages of 25 and 40 in the initial years of their professional life. The program provides travel grants for teams of participants to exchange visits between paired areas in different countries. For four to six weeks, team members study the host country's institutions and ways of life, observe their own vocations as practiced abroad, develop personal and professional relationships, and exchange ideas. Team members can come from corporations, small businesses, community organizations, medical and educational facilities, government offices, and nonprofit agencies.

On April 16th, the incoming GSE Team will be flying in from **Lebanon** and **Cyprus**. After landing, they will stay overnight in a hotel and have their orientation. They will be visiting and staying in Hunterdon County from April 17th through April 24th. **They will be the presenting program at the April 20th Flemington Rotary Club Meeting**. During their visit, they will stay with fellow Rotarians and their families, tour Hunterdon County and have a 2-day trip to Washington, D.C. April 17th: Orientation in TD Bank conference room at 1:00 PM given by Gwen and District Governor Ahmed. Each Team Member will be picked up by their Host Family at TD Bank (1 Royal Road, Flemington, NJ) @ 2:00 pm

April 18th: Meet at Gwen's house @ 8:00 am and tour Statue of Liberty and Ellis Island – We will call you to arrange time for pickup before we return

April 19th - Day: Meet at Gwen's house @ 8:30 am; go to Atlantic City - We will call you to arrange time for pickup before we return.

April 19th – Evening: Pack small bag for trip to Washington DC, Please bring just enough luggage for two days.

April 20th: Bring bag for trip and meet at Gwen's house @ 7:00 am -Vocational Morning; Gwen and Jim will transport team to the Rotary meeting where they will give their first presentation at noon, then leave for Washington DC @ 1:30pm.

April 21st: Sightseeing and then team members will have afternoon free to tour on their own.

April 22nd: Tour Capital Building and Monuments, return home - we will take team to Rotary Party; Host families pick up team members at Rotary party @ Karen Widico's house - 7:00 pm [127 Copper Hill Rd. Ringoes, NJ]

April 23th: Day spent with the host families.

April 24th Afternoon – 4:00 pm: Transfer Team Members to Somerset County Host Families @ Gwen’s house. [362 Three Bridges Rd. Hillsborough, NJ]

Effective host families will:

Welcome the team member. If possible, one or more family members should be among the welcoming delegation that meets the GSE team upon arrival in the host district. Families should introduce themselves to the team member(s) assigned to them and assure that they are looking forward to the visit.

Share their home and lifestyle. While the team member is living in local homes, the daily routine should be disrupted as little as possible. Host families are encouraged to share their culture as it exists in everyday life. This does not mean hosting elaborate parties and entertainment but allowing the guest to participate in daily family activities, religious pursuits, community involvement, etc.

Be aware of language factors. Preparation and communication are key to the success of any GSE. District governors are encouraged to appoint a team leader who is proficient in the language.

If families have difficulty communicating with their guest, they should speak very slowly and pronounce each word distinctly, separate individual words, and avoid using colloquialisms. On occasion, it may be necessary to seek help from someone fluent in the guest’s native language — the GSE team leader, a teacher, or a translator assigned by the host district’s GSE subcommittee to provide this service, or perhaps a visitor from the guest’s home country.

Provide for meals and laundry. Unless otherwise stated in the team’s itinerary, team members are usually not with their host families for lunch. Before the team member arrives, determine if he or she adheres to any dietary restrictions.

Pedals for Progress Bicycle, Sewing Machine & Sports Equipment Collection (Sat, June 4): The annual Pedals for Progress collection will be held **on Saturday, June 4, 2011**. To date, more than 117,000 bicycles have been shipped to developing countries in Latin America, Africa, and the Pacific Islands. In these countries, the bikes are reconditioned by partner agencies and distributed at low cost to poor working adults. These bikes provide them with reliable transportation for commuting to work, transporting produce to market, or accessing health care and other services. Steady employment for these adults is vital to the development and success for these economies.

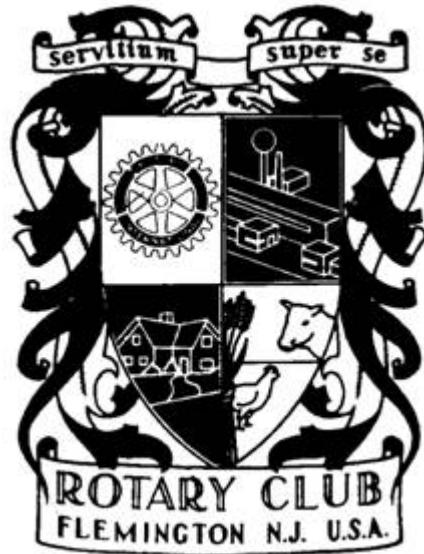
