AMENDMENTS Made to the Rotary Club of Flemington BY-LAWS

As a result of the voting by the Board and members of the club, there have been some revisions to the Club By-Laws. Please [Click Here](#) to view the complete By-Laws as they appear on the club website.

A summary of the changes made are listed below, with the changes made highlighted in yellow:

Article 2 Board

The governing body of this club shall be the board consisting of **seven (7) members** of this club, namely, **one (1) director/board member** elected in accordance with Article 3, Section 1, of these bylaws, and the President, President-Elect, Secretary, Treasurer, Lunch Treasurer, and the Immediate Past President.

Article 3 Election of Directors and Officers

Section 1 - At a regular meeting one month prior to the meeting for election of officers, the presiding officer shall ask for nominations by members of the club for President-Elect, Secretary, Treasurer, Lunch Treasurer and **one (1) director**. The nominations may be presented by a nominating committee or by members from the floor, by either or by both as a club may determine. If it is determined to have a nominating committee, such committee shall be appointed as the club may determine. The nominations duly made shall be voted for at the annual meeting. The candidates for President-Elect, Secretary, Treasurer and Lunch Treasurer receiving the most votes shall be declared elected to their respective offices. The **one candidate** for director receiving the most votes shall be declared elected as director. The President-Elect shall serve as a director for the year commencing on the first day of July next following the election, and shall assume office as President on the first day of July immediately following that year.

Article 5 Meetings

Section 4 - Regular meetings of the board shall be held **every other month**. Prior to assuming office as President and with the consent of the incoming board, the President-Elect shall determine the day and time of board meetings. Special meetings of the board shall be called by the President, whenever deemed necessary, or upon the request of two (2) directors, due notice having been given.

Article 16 Amendments

These bylaws may be amended at any regular meeting, a quorum being present, by a two-thirds vote of all members present, provided that notice of such proposed amendment shall have been mailed to each member at least ten (10) days before such

meeting. No amendment or addition to these bylaws can be made which is not in harmony with the standard Rotary club constitution and with the constitution and bylaws of RI.

These bylaws were approved by the Rotary Club of Flemington in June 2007.

On 12/4/2014, the Board (with prior club approval) voted to amend the total number of board members to seven (7) as noted in Article 2 and Article 3, Section 1.

On 4/15/2015, the Club (with prior Board approval) voted to amend the bylaws to hold board meetings every other month as noted in Article 5, Section 4.

For general reference purposes in regards to the means of communication of information, the following is Article 17 from the Club Constitution:

Article 17 Interpretation

Throughout this constitution, the terminology "mail," "mailing," and "ballot-by-mail" will include utilization of electronic mail (e-mail) and internet technology to reduce costs and increase responsiveness.

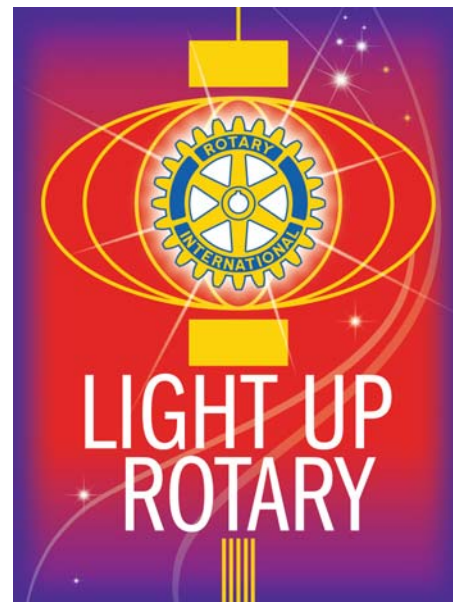
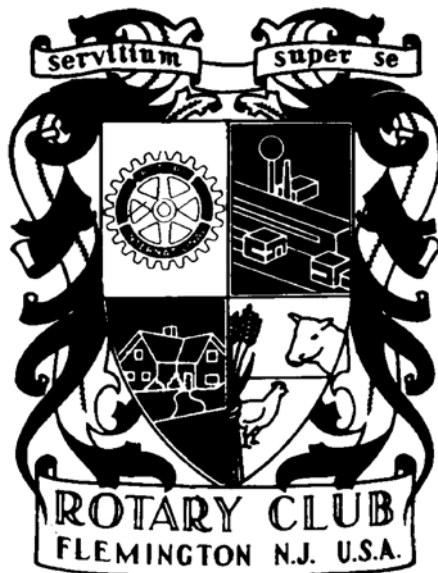
