Terry Ownes & Harry Mazujian earn highest honors at Changing of the Guard

"I'm moving back to a round table and getting to know all of you even better," said outgoing President Harry Mazujian as he passed the gavel to incoming President Bob Burgard.

Harry and long-time board member Terry Ownes were the brightest stars of the night during last week's Changing of the Guard ceremony. About 80 people turned out and saw Terry awarded as Rotarian of the Year, the club's most prestigious honor, and Harry as the 2008 Paul Harris Fellow. The 2008-2009 executive board also was sworn in.

In his summary of the past year's events, Harry reported that we end the year with 57 members, including five new members. Six members resigned, two of them given honorary status.

He said the club gave \$12,000 in charitable donations during his term and \$8,000 in scholarships to local students. He credited almost every Rotarian in the room for various roles in the past year.

"I can't believe how fast the year went," he said, and "I'm excited as ever to continue."

Following are the major awards of the night:

Rotarian of the Year

Terry Ownes was so surprised and humbled by his award that he couldn't speak after being called to the front of the room. His wife Ginger prepared a brief sketch which, piece by piece, built Terry's complete background, until most of us could name the recipient ourselves.

As Ginger tells it: Terry cooks for his family. He's neat, loves blue and white, and owns a 1979 red Fiat. He met Ginger on a blind date and proposed to her on Friday the 13th. He was one of the first babies born in the Hunterdon Medical Center in 1957. He attended a boarding school run by monks and went bald at Penn State, where he returns for every at-home football game. He loves Atlantic City and is a lucky blackjack player. He brings his dog to work every day. He's an avid boater but doesn't fish. He's on Big Boulder's ski patrol in the Poconos.

Terry owns the Rug Mart in Flemington. He is a past president of Flemington Rotary and a past Paul Harris Fellow.

Paul Harris Fellow

In the past year, Harry Mazujian attended the birthday party of a one-year-old boy who is named after him. The boy's parents are African refugees who escaped massacre in the violent Tutsi/Hutu power struggle. Harry's effort to establish a life for them in America inspired them to success.

As his wife Ruth puts it: "Harry's background is the perfect match for Rotary." And so it is. His own grandfather escaped religious intolerance in Armenia, and two generations later, Harry became a minister. He holds degrees in math, chemistry and divinity. Before becoming a minister in 1988, he had a banking career on Wall Street. To that remarkable background, add Eagle Scout, earned during his high school years in Wayne.

Harry has been a Flemington Rotarian since 2004.
