also founded and edited Third World News in Washington, DC, then was the Director of The Islamic Center in Washington, DC.

Incoming GSE Team Visit (April 16th to April 24th): Gwen Williams has shared some preliminary information on the incoming GSE Team (Group Study Exchange). The Group Study Exchange (GSE) program of The Rotary Foundation of Rotary International is a unique cultural and vocational exchange opportunity for young business and professional men and women between the ages of 25 and 40 in the initial years of their professional life. The program provides travel grants for teams of participants to exchange visits between paired areas in different countries. For four to six weeks, team members study the host country's institutions and ways of life, observe their own vocations as practiced abroad, develop personal and professional relationships, and exchange ideas. Team members can come from corporations, small businesses, community organizations, medical and educational facilities, government offices, and nonprofit agencies.

On April 16th, the incoming GSE Team will flying in from **Lebanon** and **Cyprus**. After landing, they will stay overnight in a hotel and have their orientation. They will be visiting and staying in Hunterdon County from April 17th through April 24th. **They will be the presenting program at the April 20th Flemington Rotary Club Meeting**. During their visit, they will stay with fellow Rotarians and their families, tour Hunterdon County and have a 2-day trip to Washington, D.C. Pedals for Progress Bicycle, Sewing Machine & Sports Equipment Collection (Sat, June 4): The annual Pedals for Progress collection will be held on **Saturday, June 4, 2011**. Items to be collected include <u>Used</u> **Bicycles** (adult and child), <u>Used Sewing Machines</u> (in working condition) and <u>Sports Equipment</u> (soccer balls, baseball gloves, etc. that can fit in the shipping containers between the bikes). The collection will take place at the **Flemington Presbyterian Church** located at 10 East Main Street in Flemington, NJ from **9am to 12noon**. Pedals for Progress, also known as P4P, collects over 11,000 bicycles annually and transfers this material wealth to those more needy. To date, more than 117,000 bicycles have been shipped to developing countries in Latin America, Africa, and the Pacific Islands. In these countries, the bikes are reconditioned by partner agencies and distributed at low cost to poor working adults. These bikes provide them with reliable transportation for commuting to work, transporting produce to market, or accessing health care and other services. Steady employment for these adults is vital to the development and success for these economies.

<u>8</u>th Annual RIDE FOR ROTARY – Motorcycle Poker Run, Picnic & Clam Bake (Sat, 9/17)</u>: The 8th annual family-oriented motorcycle "Poker Run" will be held on Saturday, September 17, 2011, followed by a community picnic and clam bake! The start and end location will be the <u>Clinton Elks Lodge</u>, Sidney Road (County Route 617), Pittstown, NJ. Riders check in at the Clinton Elks Lodge between 9 and 11am before leaving on the motorcycle poker run through approximately 65 miles of scenic Hunterdon County and surrounding areas. Riders will drive their motorcycles along a pre-determined route and stop to select a playing card from each of five locations. After selecting the 5th card, each rider will have a "poker hand". The first prize for best poker hand is **\$250**, second prize is **\$100** and third prize is **\$50**. The ride ends with a community picnic and clam bake at the Clinton Elks Lodge. Everyone -- non-riders, families, friends, kids, adults -- is invited to the picnic and clam bake which runs from noon to 3pm. Food, beverages, prizes, 50/50 cash raffle (tickets are \$10 each), face painting for kids, vendors and music by Krazy Kat himself! 
