Highlights from the April 2012 *The Rotarian Magazine*:

- April 4th – International Day for Mine Awareness and Assistance in Mine Action. Rotarians are working to end the use of land mines.
- April 7th – World Health Day. Disease prevention and treatment is an area of focus under The Rotary Foundations Future Vision Plan.
- April 19th – Paul Harris was born this day in Racine, Wis., USA in 1868.
- April 26th – The first mass Polio vaccine trials, involving 1.8 million children, began in Virginia in 1954.
- In January 2012, India had gone 1-year without recording a new case of polio.
- At the recent International Assembly in San Diego, RI announced that it met the Bill & Melinda Gates Foundation's \$200 Million match in funding polio eradication, raising more than \$202.6 million as of January 17, 2012.

Rotary International Foundation Contributions: As you know, all members are encouraged to “Donate \$100 Every Year” to the Rotary International (RI) Foundation. RI initially invests the money for a period of 3-years. After 3-years, RI uses the interest earned to run RI. Then 50% of the original contribution comes back to our Rotary District for our use in Grants, Ambassadorial Scholarships, and other District programs. The remaining 50% of the original contribution goes towards RI’s international humanitarian efforts, including Polio Plus and Clean Water. Once a member has donated a total of \$1000, accrued over time, they are acknowledged with a Paul Harris Recognition. A Rotarian is considered a “sustaining member” if they consistently make a donation on a yearly basis. The money raised from the Polio Bee Hives and Polio Pigs are collected to support RI’s Polio Plus program to help eliminate Polio from the world. 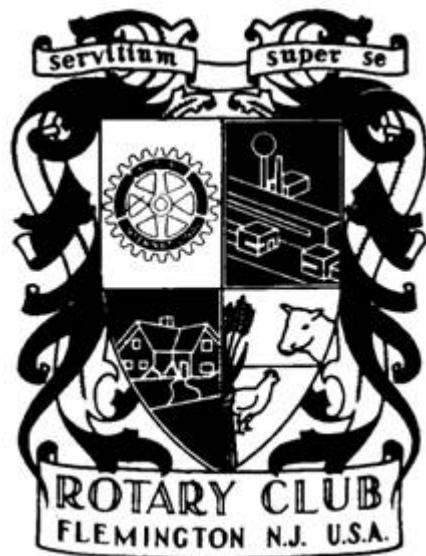
